


California LegislatureAssembly80 SeatsSenate40 Seats






Term Limits

- Change in term limits began with the 2013-2014 Legislative Session
- Three 2-year terms in Assembly
- Two 4-year terms in Senate OR
- 12 years in any one house





Recent Changes Effect on Legislature

Since 2010-2012

- § Open Primary/Top Two candidates
- § Redistricting by independent commission
- Budget passage by simple majority but any tax
 - or fee increases need 2/3 vote
 - § 2/3 Democrats in Assembly BUT less than 2/3 in Senate due to SCANDAL
 - § Massive state budget crisis easing but lots of caution to loosen spending



2016 Legislative Year

2nd year of 2-year legislative session More than 2,100 bills introduced, some "2-year" bills from 2015

Supporting bills that improve economic conditions for women, and are within the AAUW CA Public Policy Priorities




Pillars of the Women's Economic Agenda







- AAUW CA is non-partisan and cannot take positions on candidates in partisan elections, but we can educate voters on issues important to women!




What can your Branch do?

- Plan and Host a Voter Registration Drive direct, personal, targeted contact. Work with C/U partners.
- Hold an Issue Forum on topic a topic important in your community. Register voters there.
- Host a Candidate Forum
- Host a Forum on Ballot Initiatives League of Women Voters is good collaborator
- Work to Get out the Vote!




AAUW Guidelines for Election Activities

- AAUW is nonpartisan –see AAUW policies at www.aauwaction.org/voter-education/voter-guides
- Cannot expressly advocate the election or defeat of any clearly identified candidate or party.
- Focus on education about AAUW priority issues.
- AAUW CA will be taking positions on some Ballot Initiatives – these can be publicized in newsletters



- Candidate forums: invite all candidates. If branch is 501(c)(3) all candidates must attend or be represented in order to proceed with forum.
- 501(c)(4) branches can hold forum if all candidates for an office have been invited, even if only one candidate attends.
- Only 501(c)(4) branches can publish voter guides that include the position of candidates on specific issues – must include all candidates for that office.
